For long term storage, the product should be stored at lyophilized state at -20°C or lower.

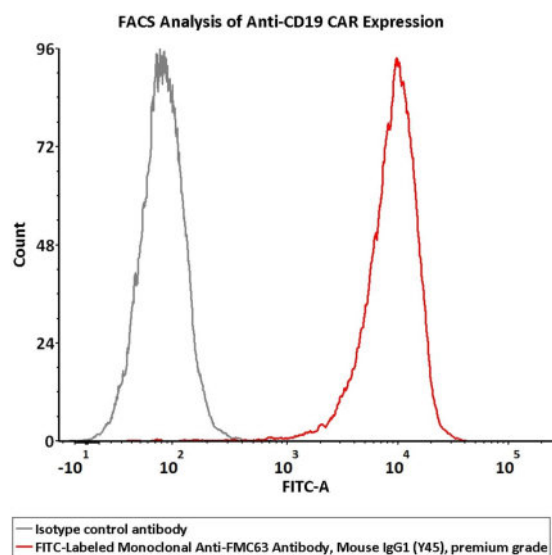
This product is stable after storage at:

- -20°C to -70°C for 24 months in lyophilized state;
- -70°C for 12 months under sterile conditions after reconstitution;
- 2-8°C for 12 months under sterile conditions after reconstitution.

2e5 of anti-CD19 CAR-293 cells were stained with 100 μ L of 1:50 dilution (2 μ L stock solution in 100 μ L FACS buffer) of FITC-Labeled Monoclonal Anti-FMC63 Antibody, Mouse IgG1 (Y45), premium grade (Cat. No. FM3-FY45G0) and Isotype control antibody respectively. FITC signal was used to evaluate the binding activity (QC tested).

Background

FMC63 is an IgG2a mouse monoclonal antibody specific for CD19, which is a target for the immunotherapy of B lineage leukaemias and lymphomas. FMC63 scFv is the most commonly used ectodomain component of CD19-specific CARs. So far, most of reported CART19 trials contain the anti-CD19 scFv derived from FMC63, including the two FDA-approved CARs Kymriah and Yescarta.
